

Selecting a Well Drilling Contractor or Pump Service

It is a good idea to obtain information about several contractors in the area prior to selecting a

water well contractor for a job.

Estimates & Written Contracts

It is recommended that you get at least 3 bids from different contractors. Get the bids in writing and make sure that the bids and estimates are for comparable materials, service, and guarantee. A low bid is not necessarily the best bargain; the contractor may not have included at the work quoted by competitors. When you select the contractor that you wish to use, it is important to obtain a written contract. You should also request that the contract provide an itemized breakdown of services and costs. Written contracts and bids might include the following:

- A statement describing the property owner's or drillers responsibility for obtaining all necessary authorizations and permits.
- A statement describing exactly what work is to be done.
- A statement that all work is to comply with local and state regulations and codes.
- Liability insurance coverage held by both the owner and the contractor
- The type of well development and yield evaluation procedures to be used and the well disinfection procedure to be used
- The type materials to be used and equipment to be installed, for example casing, screens, pumps, well caps, pressure tanks and water meters if necessary.
- The cleanup after drilling, which includes all material abandoned without authorization at a drill site except drill cuttings and wastewater
- The terms of any guarantee (contractor or manufacturer) on the well and well equipment.
- The expected date for starting and completing the work and the payment schedule



An itemized list of charges is better than a lump sum. The list could include:

- Cost of drilling per foot and Cost of casing per foot
- Cost of other materials such as drive shoe, grout, and well cap
- Cost of other operations such as grouting, developing (if longer than one hour, as in screened wells), test pumping, and disinfection
- Cost of drilling deeper and/or second well, if required to ensure an adequate water supply
- Cost of plugging and abandonment should it prove necessary (for instance, if poor water quality or low yields are encountered and another site is selected)
- A list of what costs are not included in the specifications.



Considerations

- Is the contractor familiar with the rules and construction standards of the Barton Springs/ Edwards Aquifer Conservation District?
- Is the contractor licensed with the state's Texas
 Department of Licensing & Registration? Is the license
 current and in good standing or do they have a history
 of complaints and enforcement? A well owner should
 verify this information with TDLR.

- Does the contractor have experience with drilling wells in this area?
- How long has the company been in business?
- Can the contractor provide references? Are there references available that are not provided by the contractor?
- Does the contractor submit well logs?
- Does the contractor have adequate equipment in good condition to do the job?
- Does the contractor have adequate liability and workers' compensation insurance to protect you?
- Will the contractor furnish a written contract specifying the terms and conditions of the job?



Customer Follow up

After the well has been constructed and before the contractor removes his equipment from the site, you should obtain information for your records such as:

- Well Depth, Water Level, Pump size, Casing Depth etc.
- Well Yield Ask the contractor at how many gallons per minute(gpm) the well was tested, what distance the water level dropped during the test, and how quickly the water level recovered after the test.
- Disinfection Ask the contractor if the well was disinfected.
- State Well Report Make certain that you receive your copy
 of the state well report. The contractor is required to
 provide copies of the record to the owner and the
 groundwater District. It would be advisable to keep your
 well record with your house deed so that the information is
 passed on to future owners.



Keep in Mind . . .

Trust the contractor's judgment in solving unforeseen difficulties

that may come up, and discuss unforeseen costs. If original construction plans must be changed, discuss the options with the contractor. Don't expect the contractor to work for free if the well does not fulfill expectations. Even if the well is properly constructed, the well's performance is dependent on the local aquifer conditions and may not the yield the desired quantity or quality.
